BayernLB acquires Jan-Peter Müller as Global Head of Energy & Mobility

Munich – Jan-Peter Müller will take the reins as the new head of the Energy & Mobility Division in BayernLB's Corporates & Markets Business Area as at 1 January 2022. The 37-year old joins the Bank from Commerz Real AG, where since 2017 he has been responsible for all the Group's investments in infrastructure as Head of Asset Structuring and Infrastructure Investments. In addition to this role, Müller is Managing Director (CEO) of Commerz Real S.a.r.l, and Chairman of the Supervisory Board of Veja Mate Offshore Projekt GmbH, one of Germany's largest offshore wind farms. Müller, born in Munich, began his career as a strategy consultant at Kienbaum Management Consultants in Berlin, from where, after completing a Master's degree at London School of Economics in London, he switched to the Competence Center of Energy at Commerzbank in Hamburg. Müller held several management and specialist positions in Corporate Banking at Commerzbank before joining Commerz Real.
